Anastasia Williams, DOB February 25, 2010, and listed her cause of death as; "Homicide" due to "LACERATION OF LIVER Due to: BLUNT TRAUMA TO ABDOMEN Due to: ASSAULT BY ANOTHER PERSON OR PERSONS".
